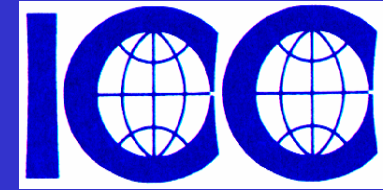
# ICC

- Founded in 1919, ICC represents the international business community in matters concerning international organisations like the UN, WTO, OECD, G7/G8.
- With independent institutions such as the Court of Arbitration, the Commercial Services as well as by providing guidelines, which promote self-regulation (e.g. Incoterms) and a vast number of publications on setting rules and standards, ICC shapes the international trading system to encourage international business.

# ICC Services

- Organisation of the World Business Congress and the World Congress of the Chambers of Commerce
- Hosting conferences with recognised experts about practical issues in international trade
- Hosting conferences and providing training on arbitration
- Services of specialised institutions such as combating commercial crime or dispute resolution services

# ICC Switzerland

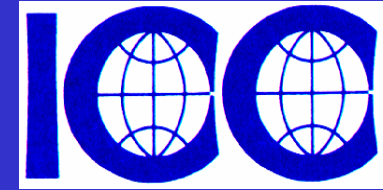


- Founded in 1922 by *economiesuisse* (formerly Vorort), the Swiss Bankers Association, and the Swiss Chamber of Commerce in France
- Committee of ICC, run by *economiesuisse*
- About 180 Members (Economic Associations in Switzerland, Chambers of Commerce, Companies, Banks, Solicitor's Offices)
- Provides access to the activities of the World business organisation
- Informs about global economic developments, influences these from a Swiss point of view, and promotes positions taken by the international business community towards Swiss politics

# Services

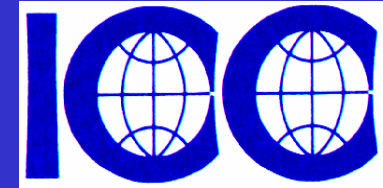
- Appoints Swiss delegates to ICC Commissions in Paris
- Submits Statements adopted by Commissions towards Swiss Authorities
- Runs the secretariat of the Swiss Commission of Arbitration, which appoints Swiss Referees in ICC procedures)

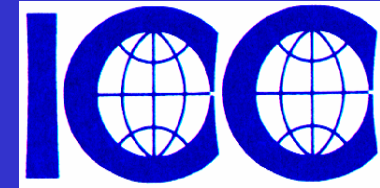

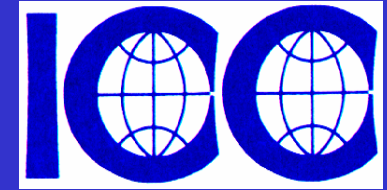
